What are <u>your</u> labels for three sources of income for a stable, steady future? How about:

- 1. YOUR PENSION
- 2. YOUR SAVINGS
- 3. YOUR SOCIAL SECURITY

1. YOUR PENSION (the basics):

A full pension (based on 30 years of service, and retirement at 70) is \$2305/month.

Each year of service is worth \$76.83/month.

You will lose 5% for every full year you retire earlier than 70 (earliest: 65 years of age).

Your Pension, continued:

Pension Plan Basics

Vesting

- You are 100% vested in your Accrued Benefit after 10 years of service (or if you are over age 70)
- Once you are vested in your Accrued Benefit, your Accrued Benefit cannot be taken away from you.
- If you leave the Archdiocese before completing 10 years of service and before age 70, you will receive no plan benefits.



The benefit formula (\$76.83/month per year of service, effective July 1, 2020) is automatically increased each year (on July 1st) based on changes in the Consumer Price Index (CPI). Annual increases are limited to no more than 3.5%

As the benefit formula increases each year, retired priests benefits will be increased at the same rate of increase.

Priests who leave ministry before age 65 do not receive benefit increases once their vested benefit commences (at age 70). Their benefit is based on the benefit formula in effect when they leave. They also are not eligible for early commencement of benefits prior to age 70.

You'll start receiving in the mail an annual statement this year of the pension benefits you have earned to date
